MULTIPLE OWNERSHIP CONSIDERATIONS

WFWI is commonly owned with five other stations in the Fort Wayne area:

WOWO	Fort Wayne, IN	1190 kHz
WONO	Fort Wayne, IN	1380 kHz
WMEE	Fort Wayne, IN	Channel 247B
WBYR	Van Wert, OH	Channel 255B
WQHK-FM	Decatur, IN	Channel 286B1

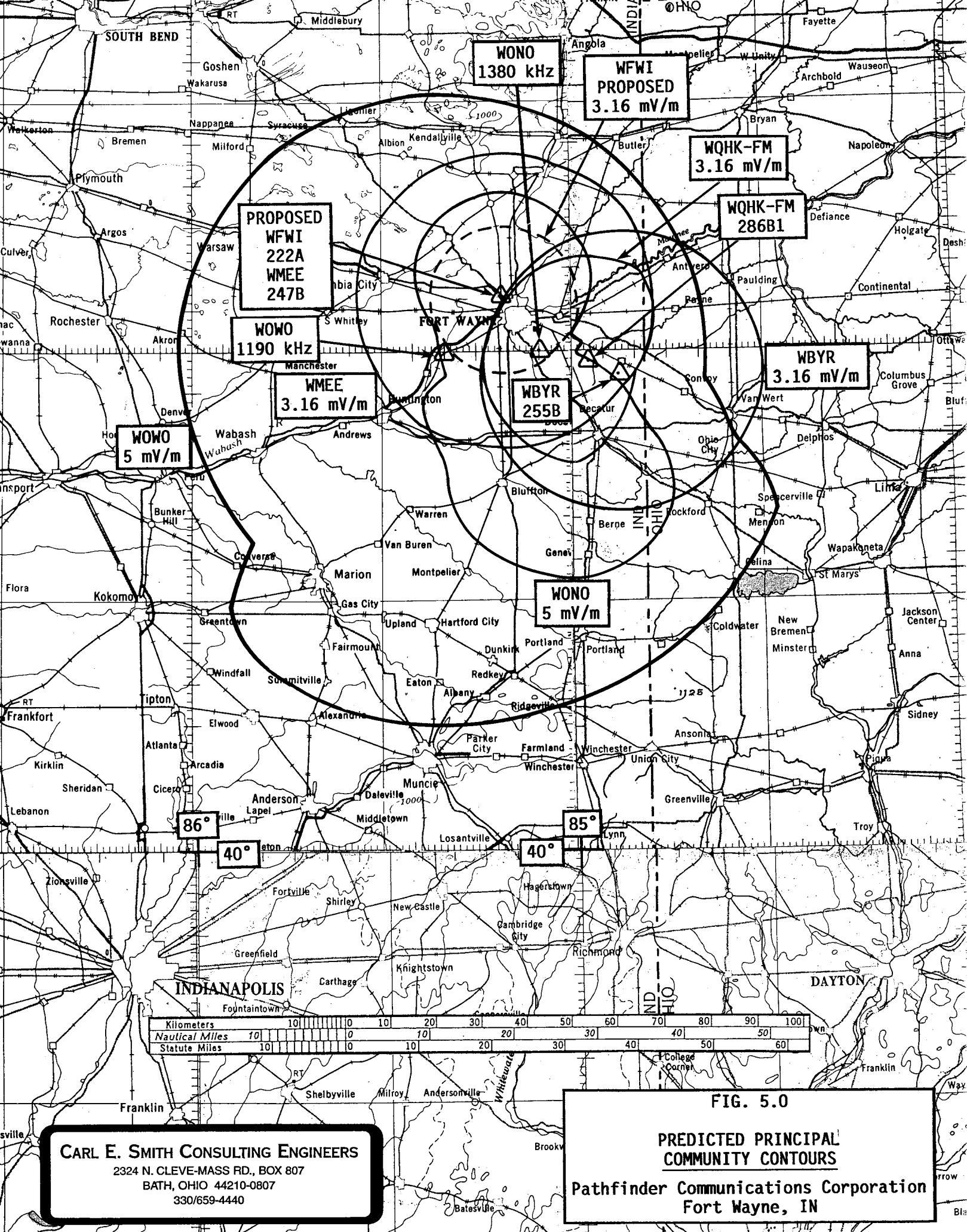
Figure 5.0 shows the predicted principal community contour for the proposed WFWI facilities in relation to the principal community contours for each of these other commonly owned stations. The 5 mV/m daytime contours for WOWO and WONO were projected using the notified daytime facilities for each station from the FCC's Consolidated Database System ("CDBS") and conductivity data extracted from FCC Figure M3. The 3.16 mV/m contours for WMEE, WBYR, and WQHK-FM were projected using the notified facilities for each of station from the CDBS and terrain data extracted from the NGDC 30 second terrain database. Finally, the 3.16 mV/m contour for the proposed WFWI facilities was projected using the facilities proposed in the attached application and terrain data extracted from the NGDC 30 second terrain database. As shown in this figure, there is an area of common principal community contour overlap between all six of these stations. Thus, all six of these stations are considered to be in a single market which contains six commonly owned stations, two AM and four FM.

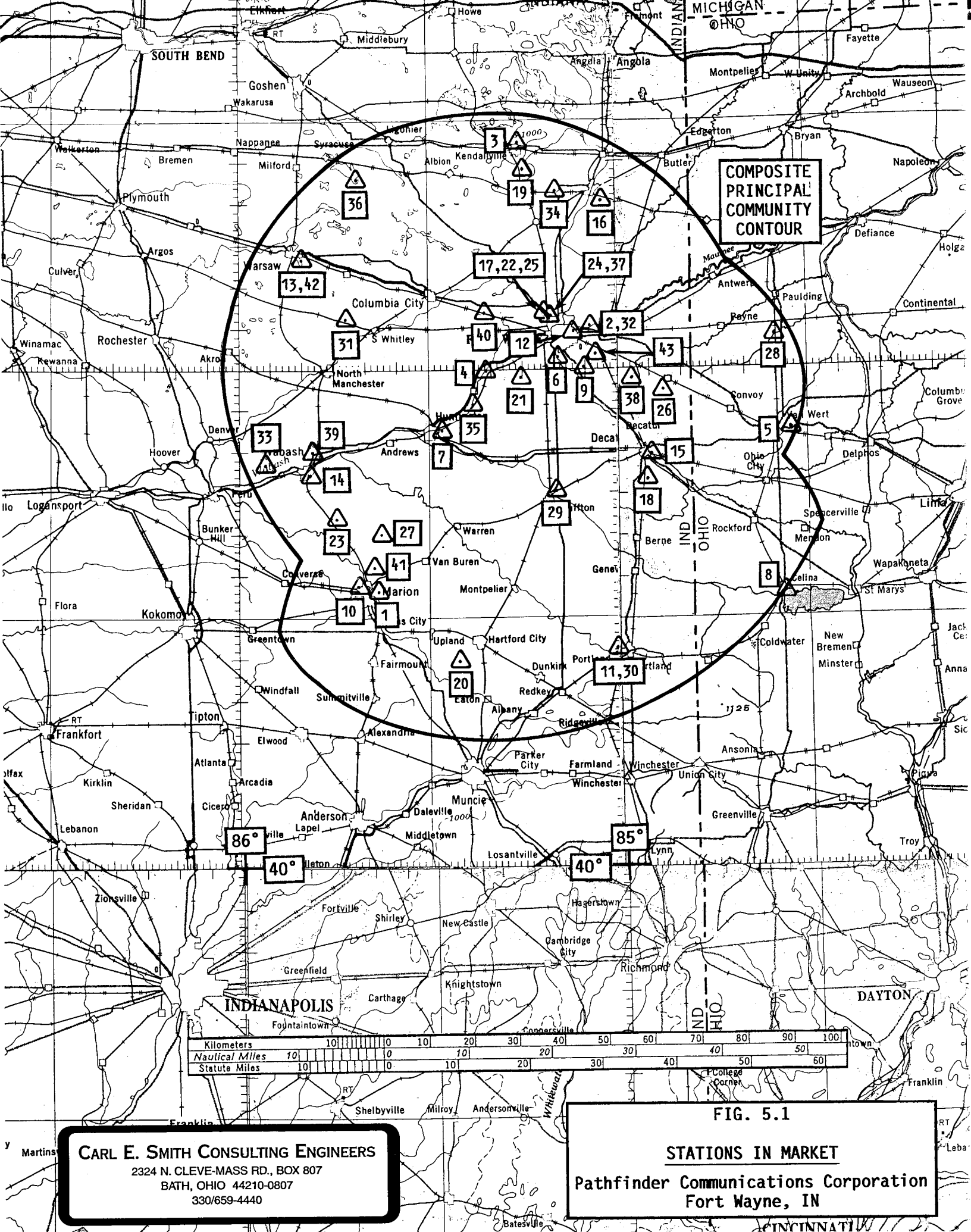
Figure 5.1 depicts the composite principal community contour for the market defined by these six stations. Also shown in this figure are the transmitter sites of all operating commercial stations that are located within this composite contour. Table 5.1 is a

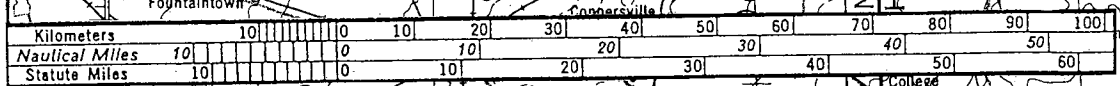
tabulation of the stations depicted in this figure. As shown by this data, there are 43 stations, including WOWO, WONO, WFWI, WMEE, WBYR, and WQHK-FM, whose transmitter sites are located within this composite contour. Since it is obvious that the principal community contour of any station whose transmitter site is located within this composite contour will overlap this contour, it can be safely said that there are at least 43 stations in this market. In fact, this number would be even greater if stations located outside this composite contour whose principal community contours overlap this composite contour were included. No such further analysis is necessary in this case, however, since, in markets containing between 30 and 44 stations, Section 73.3555(a)(1)(ii) of the FCC Rules permits the common ownership of up to seven stations, not more than four of which are in the same service. The instant situation involves the common ownership of six stations, two AM and four FM, which does not exceed the permitted maximum.

Based upon the above information, the proposed modifications to the WFWI operating facilities fully comply with the multiple ownership restrictions outlined in Section 73.3555 of the FCC Rules.
