MEDIA INTERESTS

1. Mega Communications

The sole member and total assets owner of the licensee, Mega Communications of Warrenton Licensee, L.L.C., is Mega Communications of Warrenton, L.L.C. ("Mega Warrenton"). The sole member and total assets owner of Mega Warrenton is Mega Communications, L.L.C. ("Mega L.L.C."). The sole member and 50 percent total assets owner of Mega L.L.C. is Mega Communications Holdings, L.L.C. ("Mega Holdings"). Mega Holdings currently is governed by a board of managers composed of George L. Lindemann and Adam M. Lindemann, who are also members of the company. In addition, Activated Communications Limited Partnership ("Activated") currently holds 88 percent of the total assets and 49 percent of the total membership votes in Mega Holdings.

Mega Holdings currently is the indirect parent company of the following broadcast licensees:

Applications currently are pending on FCC Form 314 for consent to the assignment of WLLH(AM) and WAMG(AM), from Mega Communications of Lowell Licensee, L.L.C. and Mega Communications of Dedham Licensee, L.L.C., respectively, to J Sports Boston LLC (FCC File Nos. BAL-20050301ADC and –ADD, respectively). In addition, applications also are pending for the *pro forma* transfer of control of the licensees of those stations, from Mega Holdings to Mega Communications of Lowell, L.L.C. and Mega Communications of Dedham, L.L.C. (FCC File Nos. BAL-200503 _____ and - ____, respectively).

2. General Electric Capital Corporation

General Electric Capital Corporation (“GECC”), an affiliate of General Electric Company (“GE”), has provided a credit facility to Mega L.L.C., which accounts for more than 33% of the total asset value of Mega L.L.C. GE wholly owns NBC Telemundo Holding Co., which indirectly owns NBC Telemundo License Co. (“LicenseCo”). According to the most recent Ownership Report on file for LicenseCo, it is the licensee of the broadcast stations listed on Attachment A-1 hereto, and indirectly controls Telemundo of Puerto Rico, which is the licensee of the stations listed on Attachment A-2 hereto, as well as Station Venture Operations, LP, licensee of the broadcast stations listed on Attachment A-3 hereto. Further information on the ownership structure of these entities is on file with the Commission as part of recent Ownership Reports filed by LicenseCo’s affiliates (*e.g.*, BOS-20040601AKW) and various other applications filed by those companies.

According to the most recent Ownership Report for LicenseCo, GE indirectly holds a 38.6% voting interest in ValueVision Media, Inc. (“ValueVision”), licensee of Station WWDP(TV), Norwell, MA, but GE neither has nor exercises control of ValueVision by virtue of this ownership interest.

According to the most recent Ownership Report for LicenseCo, GE Capital Commercial Finance, Inc. (“GECF”), an indirect wholly owned subsidiary of GE, has provided a credit facility to AAA Entertainment, LLC (“AAA”) which accounts for more than 33% of the total asset value of AAA. AAA owns and operates radio stations in various markets, including the Providence, RI, market, where it owns two stations: WWKX(FM), Woonsocket, RI; and WAKX(FM), Narragansett Pier, RI.

According to the most recent Ownership Report for LicenseCo, Duncan Ebersol has an attributable interest in the respondent based on his position as an officer of certain affiliates of GE. Mr. Ebersol and his spouse, Susan St. James, each is a Director and Vice President and owns 23.2% of the outstanding stock of Local Girls and Boys Broadcasting Corporation, the licensee of a 3,000 watt FM station, WZBG, Litchfield, CT.

According to the most recent Ownership Report for LicenseCo, Jay Ireland has an

attributable interest in the respondent based on his position as an officer or director of certain affiliates of GE. Mr. Ireland is a trustee on the Board of Trustees of St. Lawrence University, licensee of WSLU(FM), Canton, New York. The Ownership Report indicates that Mr. Ireland is not “actively” involved in management and operations of that station.

3. Cross-Interests

According to the most recent Ownership Report for LicenseCo, that company owns and operates television stations and/or holds attributable interests under the equity/debt plus (“EDP”) rule in three markets in which Mega L.L.C. owns and operates radio stations. As demonstrated below, in each case, there are at least 10 independent media voices in the relevant market, and each such EDP interest therefore complies fully with the radio-television cross-ownership rule now in effect, 47 C.F.R. § 73.3555(c).
