Dear Applicants:

The staff has before it (1) the captioned license application, filed by The Last Bastion Station Trust, LLC, as Trustee ("WMGL"); and (2) the December 26, 2007, Informal Objection<sup>1</sup> to that application filed by Georgia Eagle Broadcasting, Inc. ("George Eagle").

*Background.* On January 19, 2007, Citadel Broadcasting Company ("Citadel") licensee of WNKT(FM) St. George, South Carolina, filed an application (the "WNKT Application")<sup>2</sup> to change the community of license of WNKT(FM) from St. George to Eastover, South Carolina. On April 13, 2007, Citadel, then the licensee of WMGL(FM) filed the WMGL Application<sup>3</sup> and, on the same day, amended the WNKT Application to



make the two applications contingent with one another. No objections were filed against either the WMGL or WNKT Application, and both were granted by the staff on July 5, 2007. However, Georgia Eagle filed its Petition for Reconsideration on August 10, 2007, asking reconsideration of the grant of WMGL's application. By letter dated March 25, 2008, the staff denied Georgia Eagle's Petition for Reconsideration.

*Discussion.* To the extent that Georgia Eagle attempts to raise against the license application arguments identical to those raised in their appeal of the grant of the WMGL construction permit application, they need not and should not be examined here. Accordingly, we will deny the informal objection and grant the license application.

Accordingly, for the reasons set forth above, the December 26, 2007 Informal Objection filed by Georgia Eagle, IS DENIED, and the license application (File No. BLH-20071220ABN) for WMGL(FM) IS HEREBY GRANTED. These actions are taken pursuant to Section 0.283. The authorization will be follow under separate cover.
