


AMENDMENT to EXHIBIT 18-2
Radio Multiple Ownership

This amendment supplements two of the contour map showings submitted in Exhibit 18-2, Attachment B to the initial Transfer Applications. The Sarasota, Florida contour maps appended to the next page supplement pages B-217 through B-222 included in the initial filing. These new maps demonstrate that the combination continues to comply with the radio ownership limitations with time brokered station WBCG(FM), Murdock, Florida operating from the facilities approved in BPH-20070228AAB. Likewise, the Winchester, Virginia contour maps appended hereto supplement page B-261 of Attachment B and confirm that this combination complies with the radio ownership rules.

As noted in the original showing, in the Attachment B contour maps: dark blue lines indicate FM stations that are "home" to *and* licensed to communities within an Arbitron Metro's boundaries; light blue lines denote FM stations that are not licensed to communities within an Arbitron Metro's boundaries (these stations may or may not be "home" to an Arbitron); red lines represent AM stations that are "home" to *and* licensed to communities within an Arbitron Metro's boundaries; and orange lines show AM stations that are not licensed to communities within an Arbitron Metro's boundaries (these stations may or may not be "home" to an Arbitron).



Figure 01 - Market-Defining Principal Community Contours


