Shenandoah to host talent show July 4

Always striving to improve, members of Shenandoah's 4th of July committee have decided to host an Iowa State Fair Bill Riley Talent Search as part of the Independence Day celebration.

Chair for the event, and 4th of July committee member, Tess Gruber Nelson, explained the event will be held in the evening at Sportsman's Park, prior to the annual flag retirement ceremony and fireworks display.

"Depending on how many contestants we have, we're thinking of starting it at 6 p.m.," said Gruber Nelson. "However, we may have to move it up to 5 if we have an overabundance of contestants."

The Bill Riley Talent Search is a statewide program open to anyone residing in Iowa explained Gruber Nelson. There are three basic areas of talent, dance, vocal and instrumental. Winners in the two divisions move on to compete at the Iowa State Fair.

"The competition is between those in the sprout and senior categories, with the first place acts moving on to compete at the state level," she said. "Only one act may advance in each category."

Sprouts pertain to children two years through 12 years, while the senior division is for those 13 to 21 years of age.

Prizes will be awarded and Rick Keeton, owner/operator of Traveling Light and Sound, will provide lights and sound. Kristen Gray will serve as emcee.

"There will be three judges - one experienced in dance, one in instrumental and one in vocal. However, I haven't gotten that far yet," said Gruber Nelson. "Regardless, it's important to me the judges have no ties to

any of the contestants in order to make this competition as fair as possible.

Categories of vocals include classical, country or contemporary. Categories in dance include tap, ballet, pointe, acrobatic or baton. Acts for instrumental include classical or contemporary.

Per the rules, there are to be no more than 15 acts per division and no more than five people per act. Additionally, acts need to be kept to three minutes, with an additional setup time of only one minute.

On top of that, contestants may only appear once and can't be "professionals," explained Gruber Nelson.

Lastly, the rules state there can be no prerecorded tapes or backing vocals allowed because this is an actual talent contest and not a karaoke contest.

More specific information about the contest will be released in late May or early June. However, Gruber Nelson said getting the word out that there will be a competition, as well as the basic rules, will allow those interested in participating plenty of time to start gathering ideas and begin practicing.

Vote unanimous on revenue aims

Voters in the Sidney Community School District voted 91-0 in favor of the proposed revenue purpose statement at the election held February 7 in the district.


The revenue purpose statement gives the school district a wider range of allowed uses for the funds generated by the penny option sales and service tax levy.

Similar measures were passed in both the Glenwood and Lenox school districts, also with overwhelming approval.

The bond issue to build a new school in the Riverside School District in Oakland, failed to receive the 60% approval for passage. Only 54% of the voters approved the bond measure.

Sidney Superintendent Gregg Cruickshank said the statement's renewal until 2029, when the statewide penny tax law sunsets, gives the district flexibility on projects, such as proposed renovations to Sidney's elementary building. While he expects some sort of action in the near future, Cruickshank also believes the Sidney School Board will deal with projects on a case-by-case basis, rather than making sweeping changes to the building.

Levee repairs in county are ahead of schedule

Fremont County is closing in on an important milestone in its recovery from the flooding of 2011.

US Army Corps of Engineers briefed local and state officials on the progress of levee repairs along the Missouri River basin at a meeting in Des Moines February 8. Fremont County Emergency Management Coordinator Mike Crecelius said considerable progress has been made on levees near Percival and in Atchison County southwest of Hamburg. He added that both projects are nearing completion.

And, after delays due to property ownership issues, Crecelius said repairs on a third levee south of Hamburg are 10-to-15 percent complete. He added that contractors were confident all repairs will be completed by the March 1 deadline, which coincides with the unofficial start of the spring runoff season along the river.

Second man caught following car chase

Both suspects in February 2's high speed pursuit through Northwest Missouri and Southwest Iowa are now in custody.

The Page County Sheriff's Office said 44-year-old Alan Craig Gardner of Clarinda was arrested Feb. 9 on charges of domestic abuse and second degree theft.

Gardner was also wanted in connection with a high speed chase February 2 beginning in Burlington Junction, MO, and ending north of Hamburg.

Gardner had been on the loose since he abandoned a stolen car with 37 year old Sean Christopher Schmidt of St. Joseph. Schmidt was arrested several hours following the crash after an extensive manhunt.

Fremont County Sheriff Kevin Aistrope said Gardner walked into Clarinda Regional Health Center, where he was held by Clarinda Police officers until Page County deputies arrived.

Gardner was then transferred to the Page/Fremont County line, was taken to the Fremont County Jail to await an appearance before the county magistrate.

Bond on Gardner was set at \$50,000. He is charged with conspiracy to manufacture methamphetamines, possession of precursor anhydrous ammonia, unauthorized transport of anhydrous ammonia, possession of controlled substance-methamphetamine and second degree theft.

weather helped expedite the levee repairs. But, Crecelius said not even the last snowfall has deterred contractors.

Crecelius added that workers have been scraping snow off, piling it up on the side and carrying on with the work at hand.

Crecelius said the repairs' timely completion is a big boost to residents whose properties were damaged by flooding. Dubbed "the super levee" by some local residents, he said the levee near Percival is about twice as wide at the top as the original structure.

He also said the National Weather Service's recent projections of a drought along the river this summer make it less likely the area will experience a repeat of the severe flooding.

Skype brings two schools together for important message
