
Re: **Request for Tolling Waiver of 47 C.F.R. § 73.3598**

FM Translator Station W225BP, Coldwater, Mississippi

Dear Ms. Dortch:

American Family Association (“AFA”), permittee of FM translator Station W225BP, Coldwater, Mississippi, hereby requests a tolling waiver (47 CFR §1.3 and §73.3598) of the construction deadline for this permit pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service* 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are “presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations.”


Station W225BP has a permit that was granted as a result of the Auction 83 window filings (see BNPFT-20030310AWR, BNPFT-20130325AMN). This permit is being sold to Kid’s Television, LLC, in a separate pending application (BAPFT-20160127ACM) and will expire on May 2, 2016. Kid’s Television, LLC, has a rebroadcast agreement with the licensee of AM Station WPBQ(AM) Jackson, Mississippi. In the enclosed letter, Kid’s Television, LLC, commits to constructing the translator once the pending assignment application and proposed 250 mile window relocation application (BMPFT-20160129ARL) are granted so that the AM station can be rebroadcast as contemplated in the AM Revitalization Order.

Accordingly, AFA respectfully requests a waiver of 47 CFR §1.3 and §73.3598 to toll the construction deadline of the permit for Station W225BP (BNPFT-20130325AMN) until processing of the pending modification application filed in the 250 mile window is complete.


