Nature of Transaction

This application is one of eighteen (18) concurrently-filed applications requesting Commission consent to the *pro forma* transfer of control of the instant licensee and indirect wholly-owned subsidiaries of Sinclair Broadcast Group, Inc. ("<u>SBG</u>"), including subsidiaries which hold licenses and other authorizations ("<u>FCC Licenses</u>") issued by the Commission for full-service television stations (each a "<u>License Subsidiary</u>," and collectively, the "<u>License <u>Subsidiaries</u>"). Specifically, SBG seeks Commission approval for, *inter alia*, a *pro forma* transfer of control to allow for the formation of a new limited liability company, Illinois Television, LLC, a Maryland LLC ("<u>NewCo</u>"), that will be a direct wholly-owned subsidiary of Sinclair Communications, LLC ("<u>SCLLC</u>"), which is an indirect wholly-owned subsidiary of SBG. Following the formation of NewCo, WYZZ, Inc., which then will become a direct whollyowned subsidiary of NewCo, and which currently is the sole stockholder of WYZZ Licensee, Inc., will be merged into NewCo with NewCo being the surviving entity.</u>

As part of the reorganization, SCLLC will acquire substantially all of the assets of another of its direct wholly-owned subsidiaries, Sinclair Acquisition IV, Inc. ("Acquisition IV"). Acquisition IV currently is the sole member of WICS Licensee, LLC ("<u>WICS</u>"), WICD Licensee, LLC ("<u>WICD</u>"), and KGAN Licensee, LLC, all of which are License Subsidiaries. To promote operational synergies among its various subsidiaries, SBG desires to have SCLLC contribute (i) the membership interests of WICS and WICD, and (ii) the net assets held by each of the television stations owned and operated by WICS and WICD, respectively, to NewCo, including the FCC Licenses necessary to operate those stations. SBG's desire to simplify its ownership structure and mitigate certain regulatory compliance burdens is further reflected by the following aspects of its reorganizational plan: (i) Sinclair Television of Nevada, Inc., an indirect wholly-owned subsidiary of SBG, will be merged into its immediate parent, Sinclair Television Company, Inc. ("<u>STC</u>"); (ii) Sinclair Communications II, Inc. ("<u>SCII</u>"), the sole stockholder of STC, will be liquidated into its immediate parent, Sinclair Television Group., Inc. ("<u>STG</u>"); and (iii) each of Sinclair Television of Charleston, Inc., Sinclair Television of Buffalo, Inc., and Sinclair Television of Dayton, Inc., also will be liquidated into STC. In addition, STC will be merged into SCLLC, with SCLLC being the surviving entity. As a result of SBG's restructuring, SCLLC will become the immediate parent of all of the SBG subsidiaries that formerly had operated under STC.

The proposed transaction will not involve the exchange of any consideration, the execution of any agreements, or any substantial change in the ownership or control of any License Subsidiary. Therefore, the use of the FCC Form 316 is appropriate for the proposed transaction. *See* 47 C.F.R. §73.3540(f)(4).




