**Re: Waiver of Construction Deadline for Construction Permit
BMPFT-20161021ABI**

Dear Ms. Dortch:

Positive Alternative Radio, Inc. ("PAR") and West Virginia Radio Corporation ("WVRC") filed an assignment application with the Federal Communications Commission ("FCC") on February 8, 2016, seeking to assign the construction permit for unbuilt FM Translator Station W234CB (now W243DR), Wise, Virginia (Facility ID No. 141152) from PAR to WVRC (File No. BALFT-20160208AAY), which was granted on August 17, 2016, and consummated on August 31, 2016.

WVRC filed a "250 Mile Modification" application for W243DR, which was granted on August 22, 2016 (File No. BMPFT-20160729AFJ). The purpose of the modification is to allow WVRC to rebroadcast WCHS, Charleston, West Virginia, on the translator.

The W243DR Construction Permit is currently scheduled to expire on December 27, 2016. WVRC accordingly requests a waiver of the construction deadline for the Construction Permit pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for six months from consummation of the above-referenced assignment application on August 31, 2016.
