

Parties to the Application

As illustrated on the attached chart, 100 percent of the partnership interests in BMP 102.1 FM, LP, the proposed licensee, are held by BMP Gen Par, LLC (the sole general partner) and BMP Lim Par, LLC (the sole limited partner). The officers of BMP Gen Par, LLC and BMP Lim Par, LLC are Thomas Castro (President) and Rafael Garza (Vice President). Border Media Partners, LLC ("BMP") owns all of the membership units of BMP Gen Par, LLC and BMP Lim Par, LLC.

The membership units in BMP will be held as follows:

¹ Thomas Castro is a U.S. citizen. He currently holds an attributable interest in El Dorado Communications, Inc. ("El Dorado"), which through a wholly-owned subsidiary is the licensee of Station KQQK(FM), Beaumont, Texas. El Dorado has filed an application with the Commission to assign the license for station KQQK to Liberman Broadcasting of Houston License Corp. ("Liberman"). (*See* File No. BALH-20020426AAI.) The Commission's Media Bureau consented to El Dorado's assignment application on July 9, 2002, and El Dorado and Liberman intend to consummate their transaction before BMP consummates the transaction contemplated by this application.

² RGG Radio, LLC is a Delaware limited liability company. Thomas Castro will hold an additional approximately 4% of the Total Assets of BMP through an ownership interest in RGG Radio, LLC.

The Directors of BMP will be the managers of BMP. Except as indicated above with respect to Mr. Castro, the BMP Directors do not have any attributable ownership interests in any other media properties. The Directors are U.S. citizens.

Other than parties identified herein as attributable, the membership units of RGG Radio, LLC are held by individuals or entities insulated in accordance with the Commission's attribution rules. Over 95% of the membership units, and all attributable membership units, are held by U.S. citizens or U.S. entities. RGG Radio, LLC is managed by RGG Capital Partners, LLC. All of the membership units of RGG Capital

³ It is anticipated that most of the individuals or entities comprising this category will not be materially involved, either directly or indirectly, in the management or operation of BMP and, therefore, are insulated for purposes of the Commission's attribution rules.
