

AGREEMENT FOR SALE AND PURCHASE OF TELEVISION TRANSLATORS

This Agreement for the Sale and Purchase of Television Translators ("Agreement") is made this ___ day of July, 2007 by and between Multimedia Holdings Corporation, licensee of the FCC analog television translator licenses listed on the attached Schedule A ("FCC Licenses"), with a business address of 500 Speer Blvd, Denver, Colorado, 80203 ("Assignor") and Professional Antenna, Tower and Translator Service, with a business address of P.O. Box 1738, 12469 64.50 Road, Montrose, Colorado 81402-1738 ("Assignor") with regard to Assignee's purchase of the FCC Licenses and their associated television translators and related equipment listed on the attached Schedule A (collectively, with the FCC Licenses, "Assets") from Assignor.


THEREFORE, based on the mutual promises, covenants and consideration hereunder, the parties agree as follows:



Subject to receipt of FCC approval of the assignment of the FCC Licenses from Assignor to Assignee, Assignee shall purchase and assume from Assignor, and Assignor shall sell and assign to Assignee, the Assets for the total purchase price of Six Hundred Fifty Dollars (\$650.00) ("Purchase Price").
2. After receipt of such FCC approval, and on a closing date mutually agreed upon by the parties, Assignor shall forward the total Purchase Price to Assignee pursuant to a separate Bill of Sale.
3. All of the Assets are conveyed to Assignee "as is, where is", free and clear of all liens and other encumbrances. Assignor assumes no liabilities of any nature with regard to the condition or use of the Assets.
