The Reed Institute ("RI"), licensee of Noncommercial Educational Stations KRRC(FM), Portland, Oregon, is a non-stock, non-profit organization. RI is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of RI's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. Annual listings of the Board Members during each of the years since 1997, when the previous renewal application was filed, are set forth in the chart on the following page.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. None has any interests in any mass media other than KRRC(FM).
