Dear Ms. Dortch:

Pursuant to Section 73.3517(e) of the Commission's Rules, Cumulus Licensing Corp. ("CLC"), proposed assignee of Station WCYN-FM, Cynthiana, Kentucky, by its counsel, submits its application for minor modification of construction permit on FCC Form 301. Specifically, CLC proposes to modify this facility by installing a directional antenna at the current site. This application is contingent with the simultaneously filed construction permit application for Station WLTO(FM), Nicholasville, Kentucky, in which CLC proposes to change its transmitter location. A contingent applications narrative is enclosed to clarify the contingency between these construction permit applications.

It should be noted that WCYN Radio, Inc., and CLC have entered into an agreement for CLC to purchase Station WCYN-FM, and an assignment of license application, on FCC Form 314, was filed with the Commission on May 24, 2002. CLC, as the proposed assignee of WCYN-FM, is initiating the requested change in facility, and, therefore, includes a Consent Statement executed by Richard Anderson, Vice President of WCYN Radio, Inc., as an exhibit to the construction permit application. The WCYN-FM construction permit application is contingent upon consummation of the WCYN-FM assignment of license application pursuant to Section 73.3517(a) of the Commission's Rules.


An FCC Form 159 and the filing fee payment of Seven Hundred Fifty Five Dollars (\$755.55) will be submitted to the Mellon Bank promptly.
