

Description of Transaction

This application seeks Commission approval for the transfer of control of Cranston II, LLC, the sole Managing Member of Cranston Acquisition, LLC. The application proposes that Barbara Laurence, the Managing Member and controlling principal of Cranston II, LLC, transfer her interests in Cranston II, LLC to Beam Tilt Intermediate, LLC. At the same time Beam Tilt Corporation will transfer its interests to Beam Tilt, LLC. The proposed ownership structure complies with the Commission’s alien ownership limitations for broadcast stations.

This transaction is the first step in a two step process for transferring control of KMCC. Cranston II, LLC is separately filing today an application for pro forma transfer of control of KMCC from Beam Tilt Intermediate, LLC to Beam Tilt, LLC. That application will be contingent upon FCC approval of this application.
