Dear Mr. Hilliard:

This is in reference to the request filed on July 7, 2105. JCE requests further extension of the STA originally granted on September 23, 2003, as modified on December 11, 2003, for operation pursuant to Section 73.1615 due to the outstanding construction permit (BMP-20031024AAV). In support of the request, JCE states that the related license application (BL-20050104ABJ) remain pending before the Commission.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WFTL may continue to operate pursuant to Section 73.1615 with the substantially adjusted directional antenna facilities authorized by BP-19990521AI, as modified by BMP-20031024AAV. It will be necessary to further reduce power or cease operation if complaints of interference are received.

JCE must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

The authority granted herein is expressly conditioned on the grant of BMP-20031024AAV, and against the grant of the pending application for station WACC(AM), Hialeah, Florida (BP-19890109AB), ID# 28874. In the event that BMP-20031024AAV is dismissed or BP-19890109AB granted, the daytime antenna must be readjusted to conform with the specifications authorized by the Construction Permit (BP-19990521AI), and a new daytime proof must be conducted and submitted as an amendment to license application (BL-20050104ABJ) to cover that permit.

This authority expires on **February 5, 2016**.
