The basis was that Channel 23 had been coordinated for Station KTVB on the digital table of allotments. KTVB has, subsequently, changed its output channel.

We now have another request before the MB for use of Channel 23. This is the above-referenced STA request of Station KSGA-LP, San Bernardino, California. In that the KSGA-LP request is, obviously, for a different transmitter site than the one proposed by KSMV-LP, the MB wants to be certain that the exemption you provided would apply equally to the KSGA-LP proposal.
