Notification of changed digital operation

Dear Ms. Dortch:

Cumulus Licensing LLC ("Cumulus"), licensee of FM station WRQN, Channel 228B1, Bowling Green, Ohio, hereby notifies the Commission of a change to the operation of the station's digital broadcasting which uses the iBiquity Digital Corporation's HD Radio (TM) technology. Cumulus hereby notifies the FCC that WRQN will commence operation with a higher digital power level above the originally notified (-20.0 dB). The station's equipment makes it possible to increase to (-18.0 dB) using the iBiquity Digital Corporation's HD Radio (TM) technology. This is consistent with the Commission's Order on interim digital operations¹, and subsequent power increase Order, released January 27, 2010 (MM Docket #99-325). In support, Cumulus hereby supplies the following information.

1. Cumulus Licensing LLC plans to commence broadcasts with increased digital power on October 25, 2010.
2. Cumulus Licensing LLC hereby certifies its facilities conform to the iBiquity Digital Corporation hybrid FM specifications.



4. The transmitter power output of the analog system is 6,308 watts. The digital power output is 100 watts. The total combined analog and digital power is 6,408 watts. This is a low level combined system.
5. Cumulus Licensing LLC hereby certifies that its analog effective radiated power will remain as authorized after commencement of digital operations.
6. Cumulus Licensing LLC hereby certifies that its digital operations will not cause human exposure to levels of radio frequency radiation in excess of §1.1310 of the Commission's rules and is, therefore, categorically excluded from environmental processing pursuant to §1.1306(b).
