The instant application seeks consent to the transfer of negative control of Dickerson Broadcasting, Inc. ("DBI"). DBI was owned equally by Benjamin F. Dickerson and Ruth Dickerson, who were husband and wife, each owning 3,750 share of the corporation's 7,500 outstanding shares. Mrs. Dickerson has died, and Mr. Dickerson has inherited her shares in DBI. Attached are copies of an Order Appointing Personal Representative, Letters of Administration, and a Receipt, all reflecting the disposition of Mrs. Dickerson's stock to Mr. Dickerson.

As a 50% shareholder of DBI prior to Mrs. Dickerson's death, Mr. Dickerson is already an "approved party". DBI, owned equally by Mr. and Mrs. Dickerson, has been the licensee of Stations WEAG(AM) and WEAG-FM, Starke, Florida, for more than 17 years, during all of which time Mr. Dickerson has been a controlling owner, officer and director of the licensee.

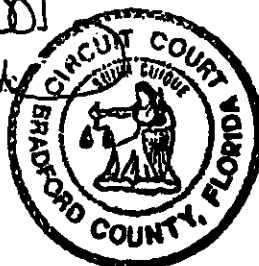


