WTZB(FM), Englewood, Florida

Change of Class from A to C3

This application seeks a facility upgrade for station WTZB (FM), Englewood, Florida, from Class A to Class C3 at a new antenna location.

The proposed antenna location is upon a tower structure identified by Antenna Structure Registration (ASR) Number 1036783 that is part of the directional array of standard band station WDDV. From this location the proposed facility will be Section 73.207 short-spaced to the facilities of WOCL, WCTQ, and WWLL, as well as the permit of WOCL. Spacing in accordance with Section 73.215 is requested with respect to these facilities and permit.

To prevent prohibited contour overlap with WOCL facility and permit a directional antenna is proposed. WCTQ and WWLL will not receive prohibited contour overlap from the proposed facility. Attached is a map demonstrating lack of prohibited contour overlap. Also attached is a map demonstrating coverage of the principal community from the proposed facility.


A fully spaced allocation location for a C3 facility has been determined to exist at a suitable location of 27-00-31 N, 82-24-04 W; an allocation location spacing report is attached. Also attached is a map demonstrating coverage of the principal community from the allocation location.

Due to the complexity of the co-located facilities, the licensee will take power density measurements prior to filing of an application for license to demonstrate compliance with 74CRR 1.1306.


73.215 Contour Map
