Dear Counsel:

This is in reference to the request filed August 23, 2010, on behalf of Perry Broadcasting of Lawton, Inc. ("PBL"). PBL requests extension of the special temporary authority ("STA") granted on February 22, 2010, to operate Station KJMZ with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, PBL states that efforts to replace its collapsed tower are ongoing.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KJMZ may continue to operate with the following facilities:

¹ KJMZ is licensed for operation on Channel 250A (97.9 MHz) with effective radiated power of 6 kilowatts (H&V) and antenna height above average terrain of 89 meters.

Channel 250 (97.9 MHz)
Effective radiated power: Not to exceed 0.5 kilowatts (H only)
Antenna height:
 above ground: 62 meters
 above mean sea level: 407 meters
 Above average terrain: 62 meters

PBL must notify the Commission when licensed operation is restored. PBL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 15, 2011**.
