Duff Ackerman & Goodrich II, L.P. has one general partner, DAG II, LLC, and more than 45 limited partners. Most of these limited partners are passive investment funds or family trust vehicles, and all but three have less than a 5% partnership interest. No fund holds as much as a 14% partnership interest, and 23 limited partners hold less than a 1% partnership interest. Section 8.7 of the DAG II, L.P. Partnership Agreement contains the language that the Commission has stated (in its instructions to the Form 314) is sufficient to insulate limited partners from attribution. This provision, which becomes effective upon the affirmation election of a limited partner, is intended to ensure that compliance with the Commission's multiple ownership rules does not become an issue with respect to the limited partners. If, contrary to its present knowledge, any limited partner has an interest that would implicate the Commission's multiple ownership rules, Duff Ackerman & Goodrich II, L.P. will take all steps necessary to ensure that such limited partner will be insulated prior to the closing of the proposed transaction. Accordingly, the limited partners are not disclosed herein.

Similarly, Duff Ackerman & Goodrich QP Fund II, L.P. has one general partner, DAG II, LLC, and more than 70 limited partners. Most of these limited partners are passive investment funds or family trust vehicles, and all but three have less than a 5% partnership interest. One fund holds more than a 10% partnership interest, and 54 limited partners hold less than a 1% partnership interest. Section 8.7 of the DAG QP Fund II, L.P. Partnership Agreement contains the language that the Commission has stated (in its instructions to the Form 314) is sufficient to insulate limited partners from attribution. This provision, which becomes effective upon the affirmation election of a limited partner, is intended to ensure that compliance with the Commission's multiple ownership rules does not become an issue with respect to the limited partners. If, contrary to its present knowledge, any limited partner has an interest that would implicate the Commission's multiple ownership rules, Duff Ackerman & Goodrich QP Fund II, L.P. will take all steps necessary to ensure that such limited partner will be insulated prior to the closing of the proposed transaction.
