Back Porch Radio Broadcasting, Inc. (“BPRB”), licensee of Noncommercial Educational Station WORT (FM-NCE), Madison, Wisconsin, is a non-stock, non-profit organization. BPRB is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of BPRB’s new Board of Directors took place pursuant its Articles of Incorporation and By-Laws. Board Members serve three year terms and Board Members appoint officers from among the Board Members. The Board consists of nine voting members. Board Members have final authority on all matters pertaining to the functioning of BPRB. Five of the board seats are filled by “participating members” as defined in the By-Laws. Three board seats are reserved for “listener members” as defined by the By-Laws. The remaining seat is reserved for a staff-selected representative. Other than the staff-designated seat which is voted on by the staff, all other vacant board positions are filled at the annual election by a vote of the participating members.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote.

The resulting transfer of control occurred, gradually over time, through routine changes in board membership. The members of the Board last submitted in a transfer of control application with the Commission (FCC File No. BTCED-20060913AAN) through the current year, following the annual business meeting each year, are:
