\*KXAM-TV operates as a satellite of KXAN-TV; WNJX-TV and WTIN operate as satellites of WAPA-TV; WJWN-TV, WKPV and WIRS operate as satellites of WJPX; and KBIM-TV and KREZ-TV operate as satellites of KRQE.

LTV's indirect subsidiary Primeland Television, Inc., has an attributable interest in television station WAND, Decatur, Illinois (70852), by virtue of its minority partnership interest in WAND(TV) General Partnership, licensee of WAND. (WAND is located in the Champaign-Decatur-Springfield DMA market and LIN TV does not have an attributable interest in another TV station in that market.)

LTV's wholly-owned subsidiary LIN Television Corporation ("LIN TV") (or an affiliate) also provides programming and advertising services under pre-November 5, 1996, "grandfathered" local marketing agreements ("LMAs") to the stations on the chart below.

Gregory M. Schmidt, an officer of LIN TV and LTV, serves on the board of directors of Banks Broadcasting, Inc., which, through subsidiaries, owns TV stations KSCW (72348), Wichita, Kansas, and KNIN-TV (59363), Caldwell, Idaho. Marcia L. Greene, an officer of LIN

TV and LTV, is also an officer of Banks Broadcasting, Inc., the sole member of WLBB Broadcasting, LLC, the licensee of KSCW, and of Banks-Boise, Inc., the licensee of KNIN-TV.

Dr. William H. Cunningham, a Director of LIN TV, is also a director of Lincoln National Corporation ("LNC"). As noted in LNC's Post-Closing Ownership Report (BOS-20060606ACB), LNC claims exemption from attribution for Dr. Cunningham, because LNC is an insurance holding company for several subsidiaries, all of which, except Lincoln Financial Media Company ("LFMC"), are engaged in insurance and insurance-related operations. Dr. Cunningham, together with a number of other LNC directors for whom exemption is sought, has no duties or responsibilities that are directly or indirectly related to the activities of LFMC or its broadcast licensee subsidiaries, nor does he exercise authority or influence (nor has he attempted to exercise authority or influence) in areas that affect LFMC or such subsidiaries. He does not own as much as five percent of LNC's stock, and he has not ever been given LNC's proxy to vote LNC's shares of LFMC. LNC's subsidiary LFMC is the parent of the licensees of the following broadcast stations: WBT (30830), WLNK (30834) and WBTW (30826), all Charlotte, North Carolina, WBT-FM (10764), Chester, WCSC-TV (71297), Charleston, both South Carolina, WAXY (30837), South Miami, WLYF (30827), Miami, WMXJ (30840), Pompano Beach, all Florida, WQXI (30825), Atlanta, WSTR (30822), Smyrna, both Georgia, KKFN (30839) and KYGO-FM, Denver, KCKK (30823) and KQKS (35574), both Lakewood, KJCD (71767), Longmont, all Colorado, KSON (30931), KSON-FM (30832), KIFM (34589) and KBZT (58816), all San Diego, KSOQ-FM (49206), Escondido, all California; and WWBT (30833), Richmond, Virginia.
