

EXHIBIT 14

STATEMENT REGARDING PENDING RENEWAL APPLICATIONS

This Exhibit 14 supplements the applications for consent to transfer control (the “Applications”) of General Electric Company’s (“GE”) indirect broadcast licensee subsidiaries. The proposed transaction contemplates that Comcast Corporation (“Comcast”), the transferee, will acquire control of all of the broadcast stations licensed to these subsidiaries. A number of the broadcast stations (including full power TV and TV translator stations) are the subject of pending applications for renewal of license. Each pending renewal application is listed in the table below:

Under Commission policy, parties may consummate a multi-station transfer of control application that overlaps the renewal cycle of a subset of the stations involved in the transaction where (1) there are no basic qualification issues raised against the transferor and transferee that cannot be resolved in the context of the transfer applications, and (2) the transferee explicitly assents to standing in the stead of the transferor in any renewal proceeding that is pending at the time of consummation of the transfer of control.¹ Pursuant to this policy, GE, the transferor, and Comcast, the transferee, confirm that, as demonstrated in the Applications and the Public Interest Statement filed therewith, there are no substantial material questions regarding the basic qualifications of either the transferee or the transferor. Further, the transferee hereby assents to stand in the stead of the transferor in any pending renewal application proceedings, consistent with the Commission’s policy.
