Kent Frandsen and Patricia Frandsen are husband and wife, and the parents of Eric and Ryan Frandsen, and have no voting or control rights over the licenses held by Sand Hill Media Group, LLC and Sand Hill Media Corporation. In addition, a shareholder holds a non-voting, non-attributable 30% equity interest in Sand Hill Media Corporation; however, as this interest is non-attributable, the other broadcast interests of the shareholder, if any, are not required to be included herein.

As noted above, Kent Frandsen and Patricia Frandsen are husband and wife, and the parents of Eric and Ryan Frandsen, and have no voting or control rights over the licenses held by Sand Hill Media Group, LLC and Sand Hill Media Corporation.
