

## Description of the Transaction

This application is one of six concurrently filed *pro forma* applications that seek Commission consent to permit the assignment of the FCC licenses associated with the operations of the following stations from their current licensee to Raycom Media Licensee, LLC:

- KNIN-TV, Caldwell, Idaho (Facility Identification Number 59363)
- WBRC(TV), Birmingham, Alabama (Facility Identification Number 71221)
- WFLX(TV), West Palm Beach, Florida (Facility Identification Number 39736)
- WVUE-DT, New Orleans, Louisiana (Facility Identification Number 4149)
- WXIX-TV, New Port, Kentucky (Facility Identification Number 39738)
- KYOU-TV, Ottumwa, Iowa (Facility Identification Number 53820)

Following consummation of the proposed transaction, all of the attributable interests in the stations will continue to be held in the same proportions and by the same persons who previously were disclosed to the Commission in the already granted long-form applications seeking approval of the merger. Accordingly, the proposed transaction meets the Commission's requirements for the use of pro forma procedures on FCC Form 316. See 47 C.F.R. § 73.3540(f)(4) (corporate reorganization without substantial change of control). The instant transaction is being undertaken solely for internal corporate purposes and there are no agreements for the sale of the stations.
