BMP Austin License Company, L.P. ("BMP Austin") is an indirect, wholly-owned subsidiary of Border Media Partners, LLC ("Border"). BMP Austin does not currently hold any Commission licenses, but it has received the Commission's consent to the assignment of:

KXXS(FM), Dripping Springs, Texas
(the "Austin Amigo Stations")
(all within the Austin, Texas, Arbitron Metro market)

² The Commission has granted consent to an assignment application pursuant to which Reding Enterprises, Ltd., licensee of KBUC(FM), will sell and assign the station to BMP San Antonio (*see* File No. BALH-20040804AAR). Upon consummation of this transaction, BMP San Antonio will become the licensee of KBUC(FM).
