**PETITION FOR RECONSIDERATION,  
WAIVER OF SECTION 73.3598(e) OF THE COMMISSION'S RULES AND  
REQUEST FOR IMMEDIATE GRANT OF  
LICENSE APPLICATION CDBS20070920ACF**

1. Max T. Nichols, permittee of the above referenced FM translator station, through counsel, hereby petitions the Media Bureau for reconsideration of the decision to cancel the construction permit of DK266AU (the "Permit").<sup>1</sup> The Permit should not have been cancelled as the facilities of Station DK266AU were timely constructed. An application for a license to cover the Permit was submitted through the Commission's Consolidated Database System ("CDBS") on September 20, 2007 (the "Application"). Unfortunately, due to a system problem with the submission of the filing fee, it was not accepted. The only problem was that the expiration date of

the permit had passed. Therefore, Mr. Nichols respectfully requests that the Bureau reinstate the Permit, waive Section 73.3598(e) of the Commission's rules to accept the Application, allow Mr. Nichols to submit the applicable filing fee and grant the Application.

2. Background. The Permit was granted on September 8, 2004, and had an expiration date of September 8, 2007. Mr. Nichols hired Ted W. Austin as a technical consultant to oversee the construction of DK266AU. Mr. Nichols also hired Fritz John Ashauer to provide technical assistance and equipment for the construction of the station's facilities. Construction of DK266AU's facilities, in accordance with the terms of the Permit, was completed on August 25, 2007. Both Mr. Austin and Mr. Ashauer have provided declarations as to their roles in completing construction of DK266AU's facilities and the date construction was completed.<sup>2</sup> The station's facilities were constructed well before the expiration of the Permit.

3. Unfortunately, Mr. Ashauer fell ill and was unable to work prior to his completing the application on FCC Form 350 for a license to cover the Permit. *See* Attachment B. Mr. Ashauer's illness forced Mr. Nichols to seek additional assistance in completing and filing the license application for DK266AU. *Id.*

4. Mr. Nichols was unable to find such assistance until after the Permit's expiration date. Mr. Nichols retained instant counsel to prepare and file the license application for DK266A U. With the assistance of a substitute engineer and counsel, the license application was prepared, and submitted through CDBS on September 20, 2007. *See* CDBS20070920ACF, a copy of which is provided hereto as Attachment C. Originally, CDBS accepted the Application. Unfortunately, the system would not accept the filing fee for the Application. This problem apparently occurred as the

Permit's date of expiration had passed. A print out of Mr. Nichols' CDBS Account showing the Application as "Not Paid" is attached hereto as Attachment D.

5. At that point, counsel attempted to coordinate the acceptance of the Application with Alan Meyers, then of the Audio Division. Mr. Meyers requested a statement from the engineer who had completed construction of the station. Mr. Meyer's suggested that if such a statement was provided to the Bureau, the Application could be granted. Regrettably, Mr. Ashauer's ongoing illness frustrated Mr. Nichols' ability to supply the statement until after Mr. Meyer's retirement.

6. Grant of Late Filed License Applications. Permittees of FM translators are required to complete construction of the facilities authorized in their permits within three years of date of grant of the permit. *See* 47 C.F.R. § 73.3598(a). According to Section 73.3598(e) of the Commission's Rules, construction permits are automatically forfeit if the facilities are not constructed in the applicable construction period and a license to cover the permit is filed before the permit expires. *See* 47 C.F.R. § 73.3598(e). Nevertheless, the Bureau has consistently granted license applications that were filed after the applicable construction permits' expiration dates, so long as the permittees "demonstrated timely construction in accordance with the terms of the permit[s]." *See* Letter, dated July 31, 2006, from Peter H. Doyle, Chief, Audio Division, Media Bureau, to Clear Channel Broadcasting Licenses, Inc., as applicant of license application BLH-20050615ACP ("CCLB"), Reference 1800B3-SS, DA 06-1550, 21 FCC Rcd 8677, pgs. 8680 to 8681 (MB 2006) (the *CCBL Letter*).

7. In the *CCBL Letter*, the Bureau accepted a late filed application for a license to cover a construction permit, BLH-20050615ACP, to modify the facilities of WRKH(FM), Mobile, Alabama, Fac. ID No. 53142. The construction permit for WRKH expired on June 13, 2005, but CCBL did not file its license application until June 15, 2005. The Bureau's decision does not state when the facilities were actually constructed, but CCBL stated in its application that the facilities were constructed according to the terms of the underlying permit. *See* BLH-20050615ACP.

8. In its application, CCBL pointed out that the Bureau had overlooked late filed license applications a number of times where the applicants claimed that construction of the applicable stations' facilities had been timely completed.<sup>3</sup> The Bureau waived Section 73.3598(e) on its own motion. The Bureau based its decision on CCBL's showing that the facilities of WRKH were timely constructed. *See CCBL Letter*, pgs. 8680 - 8681. The Bureau further determined that the CCBL did not need to re-file the license application. Accordingly, the Bureau granted the license application. Otherwise, CCBL would have had to re-file Forms 301 and 302. That procedure "would be an unnecessary burden on public and private resources, and it would delay the public service benefits associated with the modification of WRKH(FM)'s facilities." *Id.*

9. Conclusion. As Mr. Nichols has demonstrated, the facilities of DK266AU were timely constructed. Mr. Nichols attempted to submit an application for a license to cover the Permit, albeit after the expiration date of the Permit. Consistent with prior Bureau decisions, the Bureau should reconsider the cancellation of the Permit, waive Section 73.3598(e) in regard to the

## DECLARATION


I, Fritz John Ashauer, based on information and belief, declare the following:

I am an experienced electronic communications field engineer, having worked in this field for over 50 years.

Max T. Nichols hired me last summer to construct the transmission facilities for several FM translators including DK266AU, Channel 266, (101.1 MHz), West Yellowstone, Montana, Fac. ID 155904 in accordance with the construction permits for these facilities. See BNPFT-20030829AJX. I supplied the equipment and technical assistance toward its construction which was completed on August 25, 2007. Station DK266AU's permit expired on September 8, 2007.

I became ill during the early part of September 2007. I became very, very fatigued and for the next several weeks was bedridden and totally unable to do work of any kind. My local medical doctor suspected I was suffering from fibromyalgia and recommended me to a specialist in Salt Lake City. Following many weeks of tests, experimenting with various medications, it was determined that I was suffering from chronic fatigue syndrome. I am nearly 70 years old and the workload and stress I had placed upon myself during the summer of 2007 apparently brought on this illness. It was several months before I was able to resume normal activities.

Because of this illness, I was unable to finalize the paperwork associated with filing the licenses and therefore, Mr. Nichols was forced to find other outside assistance which may have delayed the filing of these license applications.

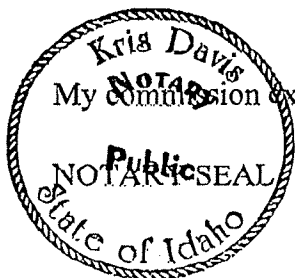
