

**STATEMENT OF COMPLIANCE WITH MULTIPLE OWNERSHIP RULES**

The proposed transaction would not result in any party to the Application obtaining an ownership interest, or combination of interests, that would violate the Commission's Multiple Ownership Rules.

**I. LOCAL RADIO STATION OWNERSHIP**

In addition to the instant application, Wilks License Company-Lubbock LLC ("Wilks") has filed an application for Commission approval of the assignment of KBTE(FM) from Dove Media, L.L.P. to Wilks. (See FCC File No. 20050713ABR). Assuming that application is granted, the grant of the instant application would provide Wilks with ownership of a total of four full-power radio stations in the Lubbock, Texas Metro.<sup>1</sup> These stations are:

There are currently 27 commercial and non-commercial full-power radio stations in the Lubbock, Texas Metro: 20 FM stations and 7 AM stations. See BIAfn FCC Geographic Market Definition for Lubbock, TX, attached herein. As such, the Commission's local radio ownership rules permit the parties to maintain a cognizable interest in up to 6 commercial full-power radio stations in that Metro, up to four of which may be in the FM service.<sup>2</sup> As the parties would control, at most, four commercial FM stations in the Lubbock Metro following the proposed transaction, the parties would be in compliance with the Commission's local radio ownership rules.

**II. JOINT TELEVISION/RADIO OWNERSHIP**

Although several parties to the Application would have cognizable interests in both radio and television stations following the proposed transaction, no combination of radio and television stations would be jointly owned in the same market. As detailed in Exhibit 13, several individuals have cognizable interests in television stations located in North and South Dakota. As the proposed transaction would involve only FM radio stations located in Texas, though, the Commission's joint television/radio ownership rules are not implicated.<sup>3</sup>
