INTERFERENCE AND SEPARATION REQUIREMENTS

IN SUPPORT OF A MINOR CHANGE APPLICATION
WRAT(FM), POINT PLEASANT, NEW JERSEY
SEPTEMBER 2015

The attached Table I and Table II show the distances¹ from the existing licensed and proposed antenna sites, respectively to pertinent existing and/or proposed FM stations on Channel 240 and ± 3 and 53/54 channels from the licensed and proposed WRAT(FM) operations. Tables I and II indicate the existing licensed and proposed antenna sites meet the minimum distance requirements of Section 73.207 of the Commission's rules to all FM stations with the exception of the "grandfathered short-spaced stations."

Table II also indicates the actual distance separation from the proposed WRAT(FM) antenna site to pertinent stations are unchanged or slightly increased when compared to the existing licensed antenna site.
