

Multiple Ownership Exhibit

The instant applications seeks FCC consent for the transfer of control of the licensee of stations KBTT(FM), Haughton, Louisiana (Facility ID No. 9221); KDKS-FM, Blanchard, Louisiana (Facility ID No. 16436); KLKL(FM), Minden, LA (Facility ID No. 13802); KOKA(AM), Shreveport, LA (Facility ID No. 9222); and KTAL-FM, Texarkana, Texas (Facility ID No. 33728) (collectively, the “Stations”).¹

Each of the Stations is located in the Shreveport, Louisiana Arbitron market. There are twenty-nine (29) full-power commercial and noncommercial radio stations in the Shreveport, Louisiana Arbitron market.² Pursuant to Section 73.3555(a)(1)(iiI), in a market of this size, *i.e.*, a market with between fifteen (15) and twenty-nine (29) (inclusive) stations, common ownership of up to six commercial radio stations in total, not more than four of which are in the same service, is permissible. Thus, the common ownership of these five radio stations, no more than four of which are in the same service, is permissible in the Shreveport, Louisiana Arbitron market.³

The transferee does not hold an attributable interest in any daily, English-language newspaper that is published in the vicinity of the Shreveport, Louisiana Arbitron market, nor does it hold an attributable interest in any full-power television station in the same market as the Stations or in the vicinity of the Shreveport, Louisiana Arbitron market.

The transferee’s proposal to acquire five full-power radio stations, four of which are in the same service, therefore, is consistent with the FCC’s multiple ownership rules.
