Dear Licensee:

This refers to interference complaints filed by Mountain Broadcasting Service, Inc. filed November 19, 2015 and all related pleadings. All complaints must be resolved. Listener complaints can be filed at any time. The complaints allege that W266AN is interfering with the reception of WSGS(FM), Hazard, Kentucky.

Pursuant to 47 C.F.R. § 74.1203, W266AN is required to eliminate any actual interference it causes. Therefore, it is necessary for W266AN to submit a detailed report on the attached complaint even if the complainant might have been addressed in a previous proceeding. For the complaint, the report must include: (1) the name and address of the complainant; (2) specific devices receiving the interference (i.e. type of device, manufacturer's name, model number, and serial number); and (3) any assistance provided by W266AN for each device allegedly receiving the interference and whether such interference persists. Each of the complaints must be addressed individually.


The Commission's Rules regarding FM translators restrict FM translator stations to operate strictly on a secondary basis and limit their service. Section 74.1203(a)(3) states that an FM translator station will not be permitted to continue to operate if it causes any actual radio signal interference to the direct reception by the public of the off-the-air signals of any authorized broadcast station.<sup>1</sup> Actual interference is based on listener complaints indicating that the signal they regularly receive is being impaired by the

<sup>1</sup> An FM translator station creating actual radio signal interference to any authorized broadcast station is obligated to eliminate the interference, regardless of the location where the impaired signal reception occurs.

signal radiated by the FM translator station. Section 74.1203(b) states that if the interference cannot be properly eliminated by the application of suitable techniques, the operation of the offending FM translator station shall be suspended and shall not be resumed until the interference has been eliminated.

Within thirty days of this letter, W266AN must take appropriate actions required by the provisions of 47 C.F.R. § 74.1203 to resolve all complaints of interference to fulfill its obligations. Further action on this complaint will be withheld for a period of thirty days from the date of this letter to provide W266AN an opportunity to respond. Failure to correct all complaints within this time may require W266AN to suspend operation pursuant to 47 C.F.R. §§ 74.1203(e) and 74.1232(h).

**OBJECTION**

Mountain Broadcasting Service, Inc. ("MBS"), licensee of FM Radio Station WSGS, Hazard, Kentucky, by its counsel and pursuant to Section 74.1203 of the Commission's rules, submits an objection to the operation of translator station W266AN, Facility ID No. 153203, licensed to Lexington, Kentucky. In support, MBS submits the following:

**BACKGROUND**


Pursuant to FCC Form 349, the then licensee of the translator station, filed an application for a minor change to the facility (BPFT-20150202AEL) (Attachment A). The purpose of the application was to change site and ERP in order to serve as a fill-in translator for WVLK(AM), Lexington, Kentucky (Facility ID No. 27418). The application was granted. See Attachment B.

The current licensee of the translator, Cumulus Licensing LLC, filed an application (BMPFT-20150831ADD) for minor modification of construction permit (Attachment C). That application was granted and a permit was issued (Attachment D). An application for license was filed (BLFT-20151013ADD) (Attachment E). The license application was granted on October 26, 2015 (Attachment F).

Attached to the instant submission is documentation from WSGS listeners complaining of interference from the translator which is preventing them from listening to WSGS (Attachment G).

Pursuant to Section 74.1203(a)(3) of the Commission's rules, an authorized FM translator may not continue to operate if it causes any actual interference to the direct reception by the public of the off-the-air signals on any authorized broadcast station. Interference occurs whenever reception of a regularly used signal is impaired, regardless of the quality of such reception or the strength of the signal. In light of the massive interference, the Commission must immediately order that W266AN cease operation. See Section 74.1203(b) of the Commission's rules.

**SUPPLEMENT TO OBJECTION**


