This technical statement has been prepared on behalf of Megahertz Licenses, LLC by Lynn A. Deppen, a technical director for the applicant. This statement supports an application for assignment for the above referenced stations.

This statement and attached exhibits will show that these stations can be owned since there are at least 43 stations in the market where common ownership consists of no more than four stations with three in one service.

Megahertz Licenses, LLC, ("Megahertz") is proposing common ownership of the above referenced three stations. Megahertz also has common ownership of several other stations in the area that overlap with stations WXMJ (FM), WWZB (FM), and WHUN (AM). These stations are WFGY (FM), WFBG (AM), Altoona, PA, and WBHV (FM), State College, PA. No other commonly owned stations overlap with stations WXMJ (FM), WWZB (FM), and WHUN (AM).

Exhibit E-2 (wxmj2.pdf) shows the locations and city grade contours of the proposed three stations for common ownership as well as the other nearby owned stations. This exhibit shows their respective 70 dbu FM (red) contours and 5 mV/m AM (green) contours. From Exhibit E-2 it can be seen that three markets emerge from this proposal for common ownership.

The first, Market 1 formed by the proposed three stations for common ownership totals three FM stations and one AM station consisting of WFGY (FM), WWZB (FM), WXMJ (FM), and WHUN (AM).

The second, Market 2 shows two FM stations and two AM stations and consists of WFBG (AM), WFGY (FM), WHUN (AM), and WWZB (FM).

The third, Market 3 is a simple AM and FM station overlap between stations WBHV (FM) and WHUN (AM).

In conclusion, stations WHUN (FM), WWZB (FM), and WXMJ (FM) as proposed for common ownership overlap with other commonly owned stations WFGY (FM), WFBG (FM), and WBHV (FM) creating three markets. Market 1 is made up of three FM and one AM stations. Market 2 consists of two FM and two AM stations. Market 3 consists of a simple AM/FM overlap. Since the stations proposed for common ownership in Markets 1 and 2 overlap with other stations 70 dbu and 5 mV/m contours to create 43 stations in each market, then Megahertz could own up to seven stations with a maximum of four in the same service. Therefore, the proposed common ownership of these stations does meet Section 73.3555(a) of the Commission's Rules since Megahertz is proposing common ownership of less than seven stations with four in the same service. Megahertz or its stockholders do not hold ownership in any other stations that overlap with the stations proposed herein for common ownership.

The station data in this statement as been taken directly from the Commission's database and all contours shown herein are calculated in accordance with the Commission's Rules.
