("CMI") is publicly-traded and is held by, among others, various investment companies, insurance companies, or other institutional investors. To CMI's knowledge, except as set forth in this table, all of these institutional investors hold less than 20% of CMI's voting stock and none of them has any influence, either directly or indirectly, over the management or operation of CMI or its subsidiaries. Furthermore, with the exception of DBBC, L.L.C. and B.A. Capital Company, L.P., both of which hold less than 5% of CMI's voting stock, none of CMI's officers or directors are associated with any of the institutional investors. All of the Class C voting stock of CMI, which is not publicly traded, is held by Mr. L. Dickey. Each share of Class C voting stock has ten (10) votes.

<sup>3</sup> This column sets forth information with respect to equity holdings only and does not include debt. The amount of CMI's outstanding debt constantly fluctuates. No party providing debt financing to CMI (or any party under common control with the debt provider) holds an attributable interest in CMI or any party under common control with CMI. Consequently, providing information as to debt holdings would have no bearing on the identification of parties with attributable interests in CMI. To the extent such information relating to debt were included, it would merely reduce the percentages of certain parties in this column in the total equity of CMI.

**Ownership Structure of Chilton Investment Company, LLC**

Chilton Investment Company, LLC ("Chilton") is an investment adviser registered with the Securities & Exchange Commission that advises and directs the investments of a number of different investment funds and managed accounts (Chilton's "Clients"). Although Chilton itself does not hold any direct interest in CMI, Chilton's Clients collectively hold approximately 6.92% of CMI's Class A voting stock. None of Chilton's Clients individually holds greater than 5% of the voting interest in CMI, and, thus, none of the Clients are attributable under the Commission's Rules. Nevertheless, because Chilton is the general partner and/or investment adviser of the Clients, controls their investments, and votes their shares in portfolio companies, details regarding Chilton's Directors, Executive Officers and Managing Member are provided below.

All of these individuals are U.S. citizens and, based on a survey conducted by Chilton, none hold an attributable interest in any FCC licenses.

It is noted that additional individuals not reported above also hold titles as officers of Chilton, but the parties listed above constitute the Executive Officers, Directors, and Members who make the decisions on behalf of the company and/or have signing authority to act on behalf of the company. Thus, the parties listed above constitute the relevant real parties in interest of Chilton.

The majority of Chilton is owned by Chilton Investment Company, Inc., which, in turn, is wholly owned by Richard L. Chilton, Jr., his family members, and entities affiliated with them. Mr. Chilton personally owns the majority of the stock of this corporation, and thus controls it as he votes more than 50% of its stock. As Mr. Chilton (indirectly) holds a majority interest in Chilton through use of the multiplier, even if the entire block of CMI's Class A voting stock owned by the various funds managed by Chilton were to be attributed to it, no other party would have an interest in 5% or more of CMI's voting stock, and, thus, no other parties would be attributable.
