Northwest Broadcasting, Inc. (“NBI”) is the General Partner of Crossover Licenses, Ltd. (“Crossover”), the proposed assignor of the license of WNKY(TV), Bowling Green, Kentucky. NBI is the sole General Partner of Northwest Broadcasting, L.P. (“NBLP”), which holds a 99% membership interest in Broadcasting Communications, L.L.C. (“BCLLC”), Mountain Broadcasting, L.L.C. (“MBLLC”), Stainless Broadcasting, L.L.C., (“SBLLC”), and Crossover Communications, L.L.C. (“CCLLC”). BCLLC is the sole Limited Partner of Broadcasting Licenses, Limited Partnership (“BLLP”). MBLLC is the sole Limited Partner of Mountain Licenses, L.P. (“MLLP”). CCLLC is the sole Limited Partner of Crossover Communications, Ltd. (“Crossover”). SBLLC is the sole Limited Partner of Stainless Broadcasting, L.P. (“Stainless”).
