EXHIBIT 1

Educational Purpose

Bridgelight, LLC ("Bridgelight") is a not-for-profit limited liability company formed for the purpose of providing educational, religious, and family programming to listeners in upper New Jersey and New York. Bridgelight is an educational and religious organization that seeks to guide individuals and communities in dealing with difficult and stressful social issues that arise on a daily basis. Earlier this year, Bridgelight Corporation applied for and received Commission approval of a license to operate as a noncommercial educational entity in Freehold, New Jersey. (File No. BALED-20021202ABO). A copy of Bridgelight Corporation's statement in support of its noncommercial educational status filed in connection with that application is attached hereto, and that statement remains fully applicable to Bridgelight. Pursuant to Commission approval, the license for WPDQ-FM was recently assigned by *pro forma* assignment from Bridgelight Corporation to Bridgelight Corporation, LLC. (File No. BALED-20030212AAF). Bridgelight Corporation, LLC changed its name to Bridgelight, LLC on April 28, 2003.

Educational Purpose

Bridgelight Corporation is a non-stock non-profit corporation formed by Cornerstone Calvary Chapel of Howell, New Jersey and Calvary Chapel of Old Bridge, New Jersey to extend the educational missions of those organizations.

As an educational and religious organization, we direct our efforts to learning and understanding the Bible as a means of learning how to live in the society of today. Problems within families, in day-to-day contacts with the business and social world at large, and among our youth, all need to be understood and dealt with. They may involve abuse of alcohol and drugs, failures in interpersonal relations among family members, acquaintances and in the workplace. We believe that a proper approach to studying and understanding social issues from a religious perspective will help individuals to make the proper choices, deal with stressful or unfortunate occurrences, and approach themselves and others in a moral and beneficial way.

We currently seek to achieve our goals in adult study groups and in groups which address the special needs and capabilities of children. Our ability to reach others, however, is limited to the time and place when teachers and those they instruct are available to meet. These limitations are serious in our case, because the adult individuals involved (including those leading the studies) have full-time jobs and/or other responsibilities which make it difficult to find a day, time and place when they all can meet. Some people cannot meet at all in these limiting circumstances.

Through ownership and operation of radio stations, we will be able to broadcast our educational materials to those who cannot appear in person, to repeat lessons at other days and times, to reach those who otherwise would not be able to receive them, and to expand the number of teachers who we can present. Regular educational programs are being planned to address social issues such as drug and alcohol abuse, marital discord, teen pregnancy and depression. Programming to meet the special educational needs of children also will be broadcast on a regular basis.
