Family Trusts

As indicated above, the Robert H. Drewry GST Exemption Trust, the William T. Drewry GST Exemption Trust and the Susan Drewry Battaglia GST Exemption Trust (the “Drewry GST Trusts”) are attributable shareholders of KSWO. The Drewry GST Trusts were each created in approximately 1995 by the exercise of a special power of appointment given by Mr. R.H. Drewry to his wife, Mrs. Jimmie T. Drewry. It was exercised after the death of Mr. R. H. Drewry. Mr. R.H. Drewry is considered to be the grantor of the Drewry GST Trusts. There is one trust each for the benefit of all of the born and unborn descendents of Mr. R.H. Drewry’s

three children – Robert H. Drewry, William T. Drewry and Susan Drewry Battaglia. Each of the three children serves as trustee for the trust for their respective descendants' benefit.

The currently living beneficiaries of the Robert H. Drewry GST Exemption Trust are Ann R. Drewry, Lisa A. Drewry Ulrich, Andrew R. Foster, Lincoln A. Foster, Angelina G. Chavez, Renee E. Ulrich and Matthew J. Ulrich. The currently living beneficiaries of the William T. Drewry GST Exemption Trust are Brett W. Drewry, Scott R. Drewry, Tracy L. Drewry, Cade W. Drewry, Maci B. Drewry, Drew A. Daft and Gunner K. Daft. The currently living beneficiaries of the Susan Drewry Battaglia GST Exemption Trust are Blake R. Battaglia, Whitney M. Battaglia, Kate P. Drewry is considered to be the grantor of the Drewry Family Trusts. Mr. R.H. Drewry is deceased. There is one trust for each of Mr. R.H. Drewry's children – Robert H. Drewry, William T. Drewry and Susan Drewry Battaglia and all of their descendants, born and unborn. Each of the three children serves as trustee for the trust for their and their respective descendants' benefit.
