

**Parties to the Application**

As illustrated on the attached chart, ultimate control of BMP San Antonio License Company, L.P. ("BMP San Antonio"), the proposed licensee, will be exercised by the managers of Border Media Partners, LLC ("BMP"), a Delaware limited liability company. Each of the BMP managers has one-fifth of the voting rights in BMP. The Managers of BMP are:

The officers of BMP are Thomas Castro (President) and Hugo Del Pozzo (Vice President).

Other than as set forth in Assignee's Exhibit No. 13, the BMP Managers and officers do not have any ownership interests in any media properties that are attributable for purposes of Section 73.3555 of the Commission's Rules. All of the BMP Managers

and officers are U.S. citizens except for: (i) Mr. Martins, who is a citizen of Bolivia; and (ii) Mr. Del Pozzo, who is a citizen of Mexico.

BMP will control the proposed licensee through its ownership of 100 percent of the membership units in BMP Gen Par, LLC and BMP Lim Par, LLC. BMP Gen Par, LLC is the sole general partner in and holds 1% of the partnership interests in BMP San Antonio; BMP Lim Par LLC is the sole limited partner in and holds 99% of the partnership interests in BMP San Antonio. The officers and managers of BMP Gen Par, LLC and BMP Lim Par, LLC are Thomas Castro (President and Manager) and Rafael Garza (Vice President and Manager).

Other than as set forth in Assignee's Exhibit No. 13, none of the attributable interest holders in BMP has any ownership interests in any media properties that are attributable for purposes of Section 73.3555 of the Commission's Rules. Holders of membership units not identified above will not be materially involved, either directly or indirectly, in the management or operation of BMP or any of its subsidiaries and will be insulated for purposes of the Commission's attribution rules. BMP certifies that its limited liability company operating agreement complies with the insulation provisions of Delaware law.

RGG Radio, LLC ("RGG Radio") is managed by RGG Capital Partners, LLC ("RGG Capital"). RGG Capital is in turn managed by Rafael Garza, who is the representative appointed by RGG Radio to serve on the BMP Board of Managers. Thomas Castro owns approximately 15% of the membership units in RGG Radio; Rafael Garza owns approximately 1% of the membership units in RGG Radio.

All of the voting rights in Santig, Ltd. ("Santig") are vested in Tony Sanchez, III, who is the representative appointed by Santig to serve on the BMP Board of Managers.

Kevin Jordan is the representative appointed by The Goldman Sachs Group, Inc. to serve on the BMP Board of Managers.
