Re: Waiver of Construction Deadline for Construction Permit BNPFT-20130826ADI

Dear Ms. Dortch:

Hope Christian Church of Marlton, Inc. (“Hope”) and West Virginia Radio Corporation (“WVRC”) filed an assignment application with the Federal Communications Commission (“FCC”) on January 28, 2016, seeking to assign the construction permit for unbuilt FM Translator Station W229CM, Facility ID 154324, Glen Burnie, Maryland (hereinafter the “Construction Permit”) from Hope to WVRC (BAPFT-20160128BCA). That application was granted on April 6, 2016, and consummated on April 14, 2016. WVRC filed a “250 Mile Modification application” for W229CM on January 29, 2016 (BMPFT-20160129AJB), which was granted on February 16, 2016. The purpose of the modification is to allow the rebroadcast of WEPM (AM), Martinsburg, West Virginia, on the translator. On April 28, 2016, WVRC and West Virginia Radio Corporation of the Alleghenies (“WVRCA”) filed a pro forma assignment application (FCC 316) with the FCC seeking to assign the Construction Permit from WVRC to WVRCA. That application was granted, and the assignment consummated, on May 11, 2016.

The Construction Permit currently is scheduled to expire on October 23, 2016. WVRCA accordingly requests a waiver of the construction deadline for the Construction Permit pursuant to Footnote 36 of the FCC’s October 23, 2015 “AM Revitalization” Order, FCC 15-142, for six months from consummation of the assignment, which occurred on May 11, 2016.


