



**ANTENNA RESISTANCE**

The antenna for translator station W245CS was installed near the top of the WYDE antenna structure. It was necessary to reconfigure one of the skirt wires to clear the antenna mounting bracket. This, along with the capacitive effect of the translator antenna, resulted in the change in antenna resistance.
