Field, minority stock ownership interests in Entercom generally do not represent attributable interests under the Commission’s ownership rules and policies. However, Entercom is providing the percentage of votes for each officer, director and reportable shareholder of Entercom as of August 1, 2006.

² The stock information provided in item 4 includes shares held of record of all classes of Entercom stock and shares for which the individual holds the sole right to vote by designation or by proxy. Certain shareholders have shared voting rights with respect to trusts and/or other entities; these voting rights, which have been excluded from the percentages set forth, would not materially alter the voting percentages.
