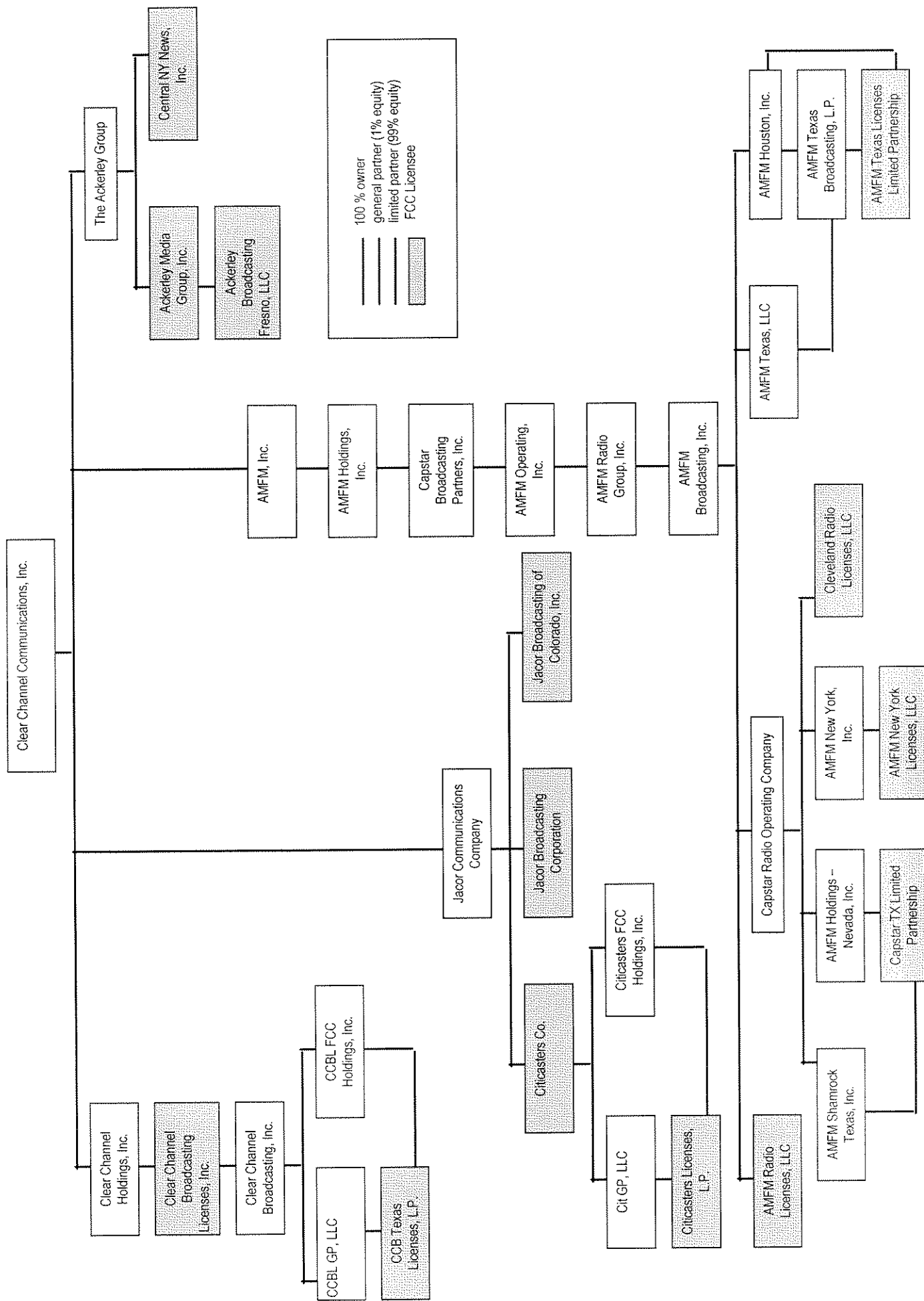


Ownership Structure of Licensee Subsidiaries of Clear Channel Communications, Inc.
