Letter of Inquiry

Dear Mr. Castro:

This letter concerns: (1) the referenced application (the "Application") of Vision Latina Broadcasting, Inc. ("Vision") for Commission consent to the assignment of the license and sale of the assets of Station KBPO(AM), Port Neches, Texas (the "Station"), to Christian Ministries of the Valley, Inc. ("Christian Ministries"); and (2) a Petition to Deny (the "Petition") the Application, filed June 26, 2009, by SouthEast Texas Telcom ("SouthEast"). In order to fully evaluate the arguments raised in that pleading, we request the additional information described below.

In its Petition, SouthEast asserts that Vision has engaged in unauthorized operation of the Station and has prematurely and without Commission authorization transferred control of the Station to Christian Ministries.¹

We direct Vision to respond to each pertinent allegation in the Objection, providing documentary support for its responses, within **thirty (30) days** of the date of this letter. Vision must serve a copy of its response on SouthEast at the address listed below. The information received in response to this letter will be used by the Commission in ruling on the Petition and the Application. Failure to respond within the time period specified may result in dismissal of the subject application for failure to respond to official correspondence pursuant to Section 73.3568 of the Rules.² We will defer action on the Application and related license renewal application³ pending receipt of the requested response.
