*KXTV, Inc.* (“*KXTV*”) is the permittee of digital television station KXTV-DT, Sacramento, California. *KXTV* has completed construction of the DTV facility authorized in the construction permit (“CP”) FCC File No. BPCDT-20080319ABE, terminated analog and pre-transition digital operations, and commenced post-transition operation on digital Channel 10.

The KXTV-DT CP contains two Special Operating Conditions. The first condition requires notification of health care facilities prior to the commencement of operation. Notification of biomedical telemetry devices became necessary when new DTV services were authorized on previously *unused* television channels. Such is not the case in this instance. KXTV-TV, analog Channel 10, has operated from the authorized KXTV-DT site for many years. As such, there should be no biomedical telemetry devices operating on 192 to 198 MHz (Channel 10). Thus, notification is not believed to be necessary.

The second Special Operating Condition restricted operation of the KXTV-DT CP facility prior to February 17, 2009. This date was extended to June 12, 2009 by Congressional action<sup>1</sup>.
