

### Description of Transaction

The instant application is one of a number of applications (“Applications”) being filed contemporaneously herewith seeking Commission consent to assign the stations listed below from subsidiaries of Tribune Media Company (“Tribune”) to Fox Television Stations, LLC (“FTS”) immediately prior to the consummation of the pending merger (the “Merger Transaction”) of Sinclair Broadcast Group, Inc. (“Sinclair”) and Tribune. Applications with respect to the Merger Transaction were filed on June 26, 2017.<sup>1</sup>

As these transactions are contingent upon consummation of the Merger Transaction, the applicants request the Commission process these Applications concurrently with the applications for the Merger Transaction.
