Dear Counsel:

This is in reference to the request filed April 29, 2008, on behalf of Radio Vision Cristiana Management ("RVC"). RVC requests extension of the special temporary authority ("STA") granted on November 1, 2007, to operate Station WWRV with parameters at variance and/or reduced power while maintaining monitor points within licensed limits, and with a nondirectional antenna and reduced power.<sup>1</sup> In support of the request, RVC states that co-located Station WWDJ continues the process of constructing modified facilities authorized by Construction Permit BP-20050719AHN.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that Application BZ-20080902AEL is pending before the Commission. Thus, the licensee has made substantial progress toward restoring licensed operation and extension of STA is warranted to allow time for processing of the application. Our review further indicates that nondirectional operation is no longer necessary; the STA will be modified appropriately.

<sup>1</sup> WWRV is licensed for operation on 1330 kHz with 10 kilowatts daytime and 5 kilowatts nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U).

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WWRV may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. RVC must notify the Commission when licensed operation is restored.<sup>2</sup> RVC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **June 12, 2009**.
