Articles of Incorporation

FOR NON-PROFIT CORPORATION

OF

ADVENTIST COMMUNITY BROADCASTING CORPORATION

1. The name of the corporation is: Adventist Community Broadcasting Corporation.
2. The address of the registered office of the corporation in Pennsylvania is: 201 Market Street, South Williamsport, Pennsylvania, 17702.
3. The corporation is incorporated under the provisions of the Non-Profit Corporation Law of 1988 for the following purposes:
 - A. For religious education, radio broadcasting, bible education, and healthful living.
 - B. To receive, maintain, and accept, as assets of the Corporation, any property whether real, personal, or mixed, by way of gift, bequest, devise, or purchase from any person, firm, trust, or corporation, to be held, administered, and disposed of exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code and in accordance with and pursuant to the provisions of these Articles of Incorporation: but no gift, bequest, devise, or purchase of any such property shall be received or made and accepted if it is conditioned or limited in such manner as shall require the disposition of income or principal to any organization other than a "charitable organization" or for any purposes other than "charitable purposes" which would jeopardize the status of the Corporation as an entity exempt from federal income tax pursuant to the relevant provisions of the Internal Revenue Code.
 - C. In general to promote and carry on any other purposes and activities for which corporations may be organized under the Non-Profit Corporation Law of the Commonwealth of Pennsylvania.
 - D. In order to accomplish the foregoing purposes, the Corporation



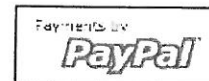

shall have all powers and only those powers permitted under the Non-Profit Corporation Law of the Commonwealth of Pennsylvania, except that, anything to the contrary notwithstanding in these Articles of Incorporation, the Corporation shall not carry on or otherwise engage in any activities not permitted to be carried on or engaged in by (i) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future tax code; or (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or any corresponding section of any future tax code.

- E. No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- F. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for a public purpose.
4. The corporation shall have no members and is organized on a non-stock basis.
5. The corporation does not contemplate pecuniary gain or profit.
