TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Leighton Enterprises, Inc. ("LEI"), licensee of KNOX-FM, Channel 234C1, Grand Forks, North Dakota. LEI is submitting a minor change (modification) application for KNOX-FM. As such, a Radio Market Analysis is needed. LEI is also the licensee of KCNN, 1590 kHz, East Grand Forks, Minnesota; KYCK, Channel 246C1, Crookston, Minnesota; KZLT-FM, Channel 282C1, East Grand Forks, Minnesota; and KNOX, 1310 kHz, Grand Forks, Minnesota. KNOX-FM, KCNN, KYCK, KZLT-FM and KNOX are each authorized to a community within a metro county in the Grand Forks, North Dakota/Minnesota Arbitron Market. Therefore, this review will verify compliance with the Commission's multiple ownership rules in a rated market.

GRAND FORKS, NORTH DAKOTA/MINNESOTA MARKET REVIEW

2. As shown on Exhibit #1, there are sixteen AM and FM (commercial and non-commercial) stations listed in the Grand Forks, North Dakota/Minnesota Arbitron Market (Market #292). LEI would be in control of three FM stations and two AM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, LEI is in compliance with §73.3555 for the reviewed market.

3. Based on compliance in the rated market, the minor change application for KNOX-FM is in compliance with §73.3555 of the rules.

4. The foregoing technical statement was prepared on behalf of Leighton Enterprises, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.


