TECHNICAL STATEMENT

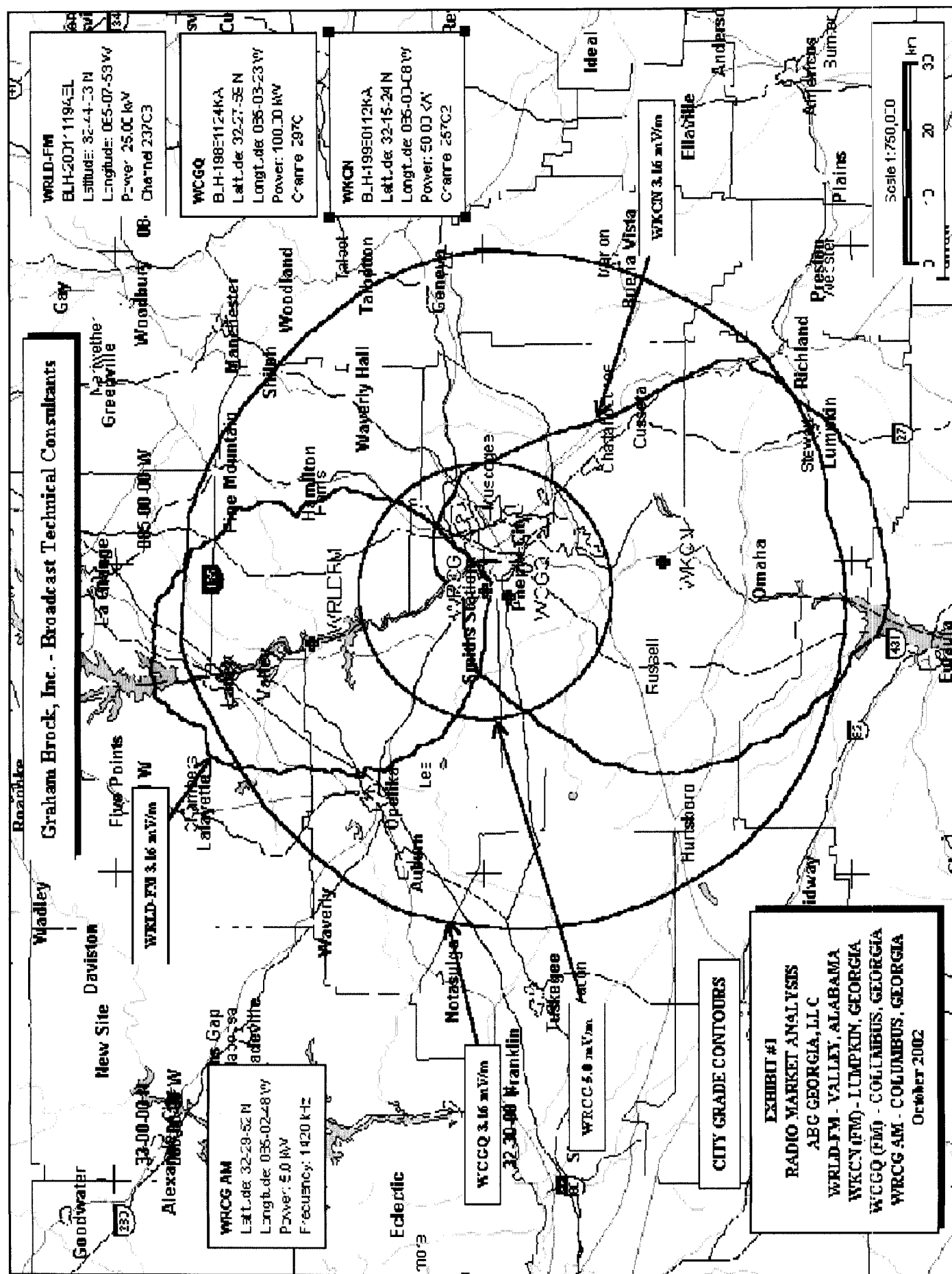
1. This technical statement and attached exhibits were prepared on behalf of ABG Georgia, LLC ("ABG"), proposed assignee of WRLD-FM, Channel 237C3, Valley, Alabama; WKN, Channel 257C2, Lumpkin, Georgia; WCGQ, Channel 297C, Columbus, Georgia; and WRCG, 1420 kHz, Columbus, Georgia. The 3.16 mV/m contours of WRLD-FM, WKN and WCGQ overlap. The 3.16 mV/m contours of the three FM stations also overlap with the 5.0 mV/m contour of WRCG. Therefore, ABG has attributable interests in three FM stations and one AM station in one market. Exhibit #1 is a map depicting the subject stations.

2. A study has, therefore, been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. The principal community contours of the three FM stations establish the market boundary, since they encompass the contour of WRCG, hereinafter referred to as the "Radio Market". These contours will be used to determine the number of other stations in the market. This study will, therefore, determine the number of commercial AM and FM stations that either have transmitter sites within the Radio Market Boundary, or have principal community contour overlap with the Radio Market Boundary.

3. Exhibit #2 is a depiction of the Radio Market with the transmitter sites or city grade contours of fifteen commercial AM and FM stations, including the four subject stations. Exhibit #3 is the tabulation of the stations in the Radio Market, including the subject stations. The total number of stations depicted in the Radio Market falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.¹ At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, ABG's interests in three FM stations and one AM station in the same market are in compliance with the Commission's rules. Therefore, ABG's proposed ownership of WRLD-FM, WKNB, WCGQ and WRCG is in compliance with §73.3555 of the rules.

All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the pertinent CDBS database. 1) There are additional stations which contribute to this market, however they were not considered since there were sufficient stations to demonstrate compliance with the Commission's rules, based on the number of stations to be commonly held.
