

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CITICASTERS LICENSES, L.P.

This statement and the attached figures were prepared on behalf of Citicasters Licenses, L.P. ("CLLP"), a licensee subsidiary of Clear Channel Communications, Inc. ("CCC"). CLLP proposes to acquire WACR-FM, Okolona, MS. A multiple ownership analysis was prepared considering the following radio stations under present or proposed common ownership, time brokerage or joint sales.¹

Since certain of these stations have overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations), or are located in, or home to, the same Arbitron Metro Market, an ownership study has been prepared in accordance with the Federal Communications Commission's local radio ownership rule.⁴

³ This construction permit, BPH20030113ABV, was filed by the current Licensee to effectuate RM-10053, which changes the WACR-FM Community of License from Columbus, MS to Okolona, MS. This change also changes the Arbitron Metro within which WACR-FM is located.

Pursuant to RM-10053, the community of license of WACR-FM-CP is now located within the Columbus-Tupelo-West Point, MS Arbitron Metro.⁵ As depicted in Figure 1, the contour of WACR-FM-CP as proposed does not overlap with the contour of any commonly owned station outside an Arbitron Metro.

Arbitron Market Study

WACR-FM-CP is geographically "Home" to the Columbus-Tupelo-West Point, MS Arbitron Metro. This proposal is in compliance with the local radio ownership rules for that Arbitron Metro, as evidenced by Table 2 below:

Interim Contour-Overlap Analysis

Because the principal community of the station to be acquired, and the communities of all commonly-owned or attributable stations with overlapping principal contours with the station to be acquired are located inside an Arbitron Metro, an interim contour-overlap analysis is not required.

Conclusions

In the Arbitron Radio Market studied herein, there are at least 28 radio stations. CCU currently has attributable interests in 2-AM / 5-FM stations which are home to the Columbus-Tupelo-West Point, MS. When the assignment of license of radio station WWKZ(FM), now pending before the Commission, is approved and consummated, CCC will have an attributable interest in 2-AM / 4-FM stations, in compliance with the media ownership limits for the Columbus-Tupelo-West Point, MS Arbitron Metro.

Based on the above, it is concluded that the proposed transaction complies with Section 73.3555(a) of the FCC Rules upon CCC's divestiture of station WWKZ(FM).
