The application is within 320 km of the Canadian border, however the Proposal complies with §73.207(b) (2), and the Working Arrangement for the Allotment and Assignment of FM Broadcasting Channels under the Agreement between the Government of Canada and the Government of the United States of America relating to the FM Broadcasting Service.

There is only one Canadian allotment considered. The Proposed site complies with Section 5.2.2.3 of the "Working Arrangement" to the CHLT-FM, class C1 station. The Proposed stations' 48 dBµ interfering contour does not cross the U.S./Canadian border. Table 1 shows the requisite distance separation to CHLT-FM along with the actual distance. Figure 2 of this exhibit shows the lack of overlap between the Proposed interfering contour and the Canadian border.

Therefore, the application complies with the requirements of section 73.207(b) (2) and the "Working Arrangement" relating to Canadian stations and allotments.


